

# LIMITED DISCLOSURE AGREEMENT

## 1.0 Joint Confidentiality During Application Review Process

All applications submitted to Northern Development Initiative Trust (“Northern Development”) are subject to due diligence procedures involving staff, consultants, regional advisors, and/or directors to ensure eligibility, alignment with program policy, and completeness.

During the application review and due diligence period, Northern Development agrees that the information contained in the application will remain strictly confidential and be used with utmost discretion. The Company (“Applicant”) agrees that any correspondence, follow-up information, and contract details with respect to the application will remain confidential between the two parties.

Once an application is approved in principle, Northern Development reserves the right to publicly disclose discrete aspects of the funding commitment as specifically outlined below (2.0 Limited Disclosure Once Approved In Principle). The purpose of this disclosure is to inform the general public with regard to private industry initiatives supported by Northern Development and the Capital Investment and Training Rebate program.

## 2.0 Limited Disclosure Once Approved In Principle

A. The Applicant agrees that Northern Development may publicly announce and include within its website reporting and marketing materials specifics regarding this rebate limited to:

- Company name
- Description of the Company
- Facility location
- Anticipated job creation
- Form and estimated value of the capital investment anticipated (if applicable)
- Form of training program anticipated (if applicable)
- Anticipated value of rebate funding to be provided by Northern Development Initiative Trust
- Beneficial impacts to central and northern BC communities arising from the Applicant’s location or expansion initiative

All other information relating to financial reports, financial projections, business plans and commercial strategies shall not be disclosed at any time.

B. The Applicant agrees that Northern Development’s public announcements may include:

- A media release issued by Northern Development upon approved in principle status of the Applicant’s application
- Installation of Northern Development signage at the Applicant’s facility (or at the site location during construction, if applicable) recognizing the contribution of Northern Development to the Applicant’s expansion initiative, and noting the anticipated number of new employment positions directly created

C. The applicant agrees to provide the following to Northern Development in order the support publicity for the project:

- A testimonial from an executive of the Company regarding the assistance provided by Northern Development to enable the establishment or expansion of the company within central and northern BC
- Contact information for Company representative(s) to liaise with media on behalf of the Company regarding the announcement(s) for the project

- Attendance of the Applicant’s supply chain or procurement management personnel and/or executives at Northern Development coordinated procurement forums, should the project entail significant capital expenditure. The Applicant will provide access to its procurement process(es) and advise relevant local/regional suppliers how to bid on aspects of the location or expansion project.

*Northern Development will not issue any further information regarding the Applicant other than that specified above or as agreed on a case-by-case basis, in writing, with the Applicant.*
